Recently, the "Famous Trademark Brand Tutoring Team" of Sanyou, in collaboration with Zhonggui Certification, a third-party professional certification firm, conducted a comprehensive and detailed on-site evaluation of the AAA well-known trademark brand "桃李" applied for certification at TAOLI Bread Co., Ltd.



At the end of 2022, the China Trademark Association released the Norms for the Evaluation of Well-known Trademark Brands (T/CNTA002-2022) group standard, providing scientific and standardized guidance for enterprise brand building. Sanyou has successfully completed the training, examination, and filing procedures in accordance with the relevant regulations of the China Trademark Association, and meets all the conditions for engaging in "AAA Famous Trademark Brand Evaluation and Consulting Services". Sanyou is capable of providing evaluation and consulting services for well-known domestic and foreign brands, and by promoting evaluation of well-known trademark, enterprises could expand their business through brand building.

A brand that has obtained the AAA well-known trademark / brand recognition is a trademark brand that is known to the relevant public and enjoys a high reputation in a certain region and related industries. It is more distinguishable from other enterprises' goods or services in market competition, effectively preventing other enterprises from using similar or identical trademarks, and is also more likely to obtain legal protection in the event of trademark infringement and disputes. Currently, this certification is open to international enterprises, and enterprises that have passed the AAA (national level) well-known trademark / brand evaluation will be issued a certificate by the China Trademark Association.
